AOS Strategic Plan: Looking to the Future

In October 2023, the AOS Council approved a new strategic plan, a guiding document that will help us meet the needs of our community, now and into the future. We used feedback from our 2022 culture survey and 2023 strategic planning survey to understand our members' priorities and needs. Several of our core functions will remain consistent: the AOS will continue to publish high-quality journals, provide opportunities to exchange scientific ideas and build community at our annual meetings, and distribute grants to support ornithological research. Under this strategic plan, we also integrate elements of diversity, equity, inclusion, belonging, and justice across all of our goals and programs, and we focus on excellence in governance and operations to ensure that we have the foundation to support priority work in a thriving organization. AOS Strategic Goals

Supporting impactful ornithological science

Ornithologists, with an emphasis on early-career members and those from under-resourced regions of the Americas, have access to resources to conduct ornithological research that advances the understanding and conservation of birds.

Communicating and providing access to ornithological science

High-quality ornithological research is broadly accessible through publications, Society events (virtual and in-person), and other effective communications.

Broadening and strengthening professional development and career support

AOS values and welcomes ornithologists of all career types and supports continued development across all professional stages.

Fostering an inclusive ornithological community

AOS promotes an inclusive culture and diverse membership where everyone feels a sense of belonging. We create an ornithological community that connects, values, and empowers all ornithologists from different disciplines, career paths, and geographic regions, as well as from different backgrounds, experiences, and identities.

Commitment to DEIBJ

Diversity Equity Inclusion Belonging Justice

DEIBJ values statement & resources

One of the core goals of the AOS is to foster an inclusive ornithological community that connects, values, and empowers ornithologists representing a variety of interests, backgrounds, career paths, and needs. In 2023, we introduced a revised statement that strengthens and expands the AOS's commitment to diversity, equity, inclusion, belonging, and justice (DEIBJ) and guides our conversations around these core values. We have a suite of resources and initiatives to support this goal.

English bird names commitment

The discussion of English bird names was a key area of work in 2022 and 2023. In 2022, the AOS appointed an ad hoc English Bird Names Committee to develop recommendations for a process that would allow the AOS to thoughtfully and proactively change harmful and exclusionary English bird names within its jurisdiction; that Committee completed its work in 2023 and presented recommendations to the AOS Council in August 2023. After extensive consideration, the AOS made several commitments:

- The AOS will change all English-language names of birds within the AOS's jurisdiction that are named directly after people (eponyms), focusing first on those species that occur primarily within the United States and Canada.
- The AOS will establish a new committee to oversee the assignment of English common names.
- We will engage the public in proposing new common names.

In 2024, the AOS will launch a pilot that will allow us to develop, evaluate, and refine a new approach to English bird names in the U.S. and Canada. We look forward to collaborating with our members, partners, and the public on this ground-breaking initiative.

Affinity groups to build community

Professional scientific associations can play key roles in shaping the culture within their fields, cultivating supportive communities, and providing resources to ensure that all scientists have the professional and personal support they need to succeed on their chosen career path. In 2023, AOS Councilor and Diversity & Inclusion Committee Co-Chair Dai Shizuka (University of Nebraska–Lincoln) and AOS member Ashley Dayer (Virginia Tech) received a two-year NSF BIO-LEAPS grant to work with three ornithological societies to strengthen the sense of community for individuals from groups that have been historically marginalized in the field of ornithology. The AOS, the Wilson Ornithological Society, and the Association of Field Ornithologists are collaborating on an initiative to address the need for cultural change within ornithology and to create supportive affinity groups for ornithologists.

Annual Meeting 2023

As one of the AOS's flagship programs, our annual meetings provide the opportunity to achieve multiple AOS goals, from communicating ornithological science, to broadening and strengthening professional development, to fostering an inclusive ornithological community.

In August 2023, the AOS partnered with the Society of Canadian Ornithologists–Société des ornithologistes du Canada (SCO–SOC) to host

813 participants from **39 countries** for an incredible scientific conference in London, Ontario, Canada. The meeting's theme, "**Birds as Bridges**," supported our commitment to use a shared love of birds to connect people from different geographies, identities, and perspectives.



Featuring science ranging from urban ecology to automated radio telemetry, our meeting also featured insights from keynote speaker **Gary Pritchard ~Giniw (Golden Eagle)** on how to better partner with Indigenous peoples, and many opportunities to socialize and build professional and personal networks.

We had **144 students** and **71 judges** participate in our Student Presentation Awards competition. Our **Shorebird Shuffle Fun Walk/Run** attracted **126 "early birds**," and students from eastern Canada warmed up the crowd with enthusiastic dancing at our **Closing Reception**.

The 2023 conference was a joyful celebration of science and belonging within our amazing ornithological community. **More than 90% of meeting attendees were satisfied** with the meeting, and the vast majority were satisfied with the AOS's efforts to expand inclusion and representation. With **more than 30% of participants being first-time conference attendees**, our Annual Meeting is an important opportunity to welcome the next generation of ornithologists while providing a professional "home" for ornithologists throughout their careers. We can't wait to see everyone in Estes Park in 2024!

Annual Meeting 2023

Supporting broad participation

Birds as BRIDGES: Belonging, Respect, Inclusion, Diversity, Growth, and Equity are key principles of the AOS Annual Meetings, and our programming highlighted critical science while providing space to share perspectives and build community among scientists. The **Rainbow Lorikeets** hosted both a popular panel on increasing inclusion and belonging for 2SLGBTQIA+ (two-spirit, lesbian, gay, bisexual, transgender, queer, intersex, and asexual) ornithologists, and a Sunrise Social attended by more than 50 2SLGBTQIA+ folks and allies. The meeting also featured a lunchtime roundtable discussion, "Perspectives on birding and ornithology from the Deaf and hard of hearing," which brought together five deaf and hard-of-hearing panelists who work in ornithology to share their experiences, identify barriers, increase awareness, and call for increased accessibility and inclusion at professional meetings. Our "Golden Auks" luncheon brought together retired members of our ornithological

community. The AOS continues to take steps to ensure that our Annual Meetings are welcoming to and meet the needs of all members of our community.

The AOS's travel grants program plays an integral role in administering funds to bring members to our annual conferences. These funds are instrumental in creating an accessible and inclusive AOS and providing networking and professional development opportunities for students, post-docs, and others who might otherwise struggle to attend our meetings. In 2023, the AOS provided a total of \$155,399 of support to 212 conference attendees: 26% of conference attendees received travel support from the AOS.

2023 Travel & Caregiver Grants

In addition to \$136,972 of general Student and Post-doc Travel Grant funding allocated across 183 individuals, the AOS provided meeting participation support tailored to meet more of our members' specific needs.

- Caregiver Grants provide funding to enable those with child- or elder-care responsibilities to participate in our conference; in 2023, the AOS awarded **five** Caregiver Grants totaling **\$3,775**.
- Diversity and Inclusion (D&I) Grants support students and post-docs from underrepresented groups and/or those who have made significant contributions towards fostering a diverse and inclusive community. In 2023, this program supported **22** participants for a total of **\$9,652**.
- The AOS piloted a Latin American and Caribbean student travel grant program in 2023 with an earlier acceptance cycle; this helps accommodate the unique time considerations and constraints of attendees who need to obtain visas to participate in the meeting. The AOS received **37 applications** for these grants, and we funded **two** grants in this program's inaugural year, totaling **\$5,000**.

In addition to providing general funds to support students and post-doc participation at our Annual Meetings, offering more tailored support ensures that our meetings are accessible to a broader range of ornithologists.





AOS Journals

2023 marked the third year of publishing our journals under their new names, *Ornithology* and *Ornithological Applications*, in partnership with Oxford University Press. The 2022 impact factors, published in June 2023, resulted from citations to articles in our journals in 2020 and 2021. Given that the names of the journals were *The Condor* and *The Auk* in 2020, and *Ornithological Applications* and *Ornithology* in 2021, we have two sets of 2022 impact factors. **In a sweep of the impact factors in the ornithological category**, *The Condor* and *The Auk* have the two highest impact factors (3.1 and 2.8, respectively) and *Ornithological Applications* and *Ornithology* have the next two highest (2.4 and 2.3)*. Therefore, **our two AOS journals hold the top-ranked** *four* **slots in the**

ornithological category, something akin to a rare comet circling Earth and an unusual success to celebrate!

The AOS has worked to increase the publication of high-impact papers and to expand the types of papers we publish. Review papers are consistently the most cited article types for our journals, and we published five in 2023, including two submissions for the second Wesley Lanyon Award competition: "The biotic and abiotic drivers of

timing of breeding and the consequences of breeding early in a changing world" (Sutton and Freeman, 2023); and "Studying individual-level interactions can transform our understanding of avian mixed-species flocks" (Vander Meiden et al., 2023). Other noteworthy papers published in *Ornithological Applications* were "Accelerating declines of North America's shorebirds signal the need for urgent conservation action" (Smith et al., 2023); and "Lead, trash, DDE, and young age of breeders linked to lower fertility in the first two decades of reintroduction for critically endangered California Condors in California" (Bakker et al., 2023).

A call to action: supporting neotropical ornithologists

In early 2023, AOS published two articles in *Ornithological Applications* that called on the AOS and other scientific organizations to better support and recognize Neotropical ornithologists: "Neotropical ornithology: Reckoning with historical assumptions, removing system barriers, and reimagining the future" (Soares et al., 2023); and "How to include and recognize the work of ornithologists based in the Neotropics: Fourteen actions for *Ornithological Applications*, *Ornithology*, and other global-scope journals" (Inzunza et al., 2023), which received significant media attention, including a news story in *Science*. These articles served as a call to action for the AOS, and our editorial team is working with Latin American colleagues on next steps, which included publishing an article highlighting significant contributions to Colombian ornithology by Elizabeth Kerr: "The once-invisible legacy of Elizabeth L. Kerr, a naturalist in the early 20th century, and her contributions to Colombian ornithology" (Soto-Patiño et al., 2023).

Student & Post-doc Awards & Research Grants

The AOS research awards provide critical funding to launch and sustain student and post-doctoral research across a wide variety of disciplines and institutions. In 2023, AOS provided **\$185,395** in research support, a **37.7% increase** over 2022; **\$115,395** of these funds supported **50** student and post-doctoral research grants to recipients from six countries. In addition, we awarded four Kessel Fellowships in 2023, research grants of \$15,000 each to support post-docs and early-career professionals as they launch their research careers; and two Latin American/Caribbean Conservation Research Grants of \$5,000 each.

The AOS also recognizes outstanding student scientific contributions to our annual meeting with a variety of presentation awards. Finally, we provided 32 AOS-sponsored Student Memberships to first-time student members in 2023, to help grow our community.

Latin American/Caribbean Conservation Research Grants

Our commitment to connected science

In 2023, the AOS Conservation Committee launched a new Latin American and Caribbean Conservation Research Grants (LACCRG) program, which was a resounding success. Given the substantial declines of North American bird populations over the last 50 years, investigation of the underlying mechanisms across the full annual cycle is critical to reversing declines. Many North American birds over-winter in the Caribbean, Central America, and South America, and the majority of species south of the U.S. border remain entirely unstudied.

Simultaneously, the resources available to support avian researchers and study outside of the U.S. and Canada are relatively limited. The LACCRG program was therefore developed to support 1) research endeavors focused on avian species of concern across the full annual cycle, and 2) early-stage researchers from Latin America and the Caribbean. As such, the initiative aligns with key foci in the new AOS Strategic Plan, including supporting science that advances the understanding and conservation of birds, and fostering an inclusive ornithological community. The inaugural call for proposals yielded **41** outstanding applications from **12** different countries. The Conservation Committee was proud to support **two deserving projects** in the pilot year of this program and looks forward to expanding this initiative in the future.





*The AOS had sufficient cash on hand to cover these expenses in 2023, so additional draws from our endowment were not required. The AOS is in a strong financial position to cover all expenses in the annual budget.

**Note that figures on this page represent preliminary, unaudited numbers as of 31 December 2023. The AOS operates with a balanced budget, using annual operating income and annual draws from endowed funds, both restricted and unrestricted. Endowed funds are managed to continue to provide support for our programs in perpetuity.


